About our research

Combining the expertise of more than two dozen tenure-track faculty, the Department of Management and Entrepreneurship spans virtually every topic within the four core areas of management (strategic management, organizational behavior, organizational theory, and human resource management) and the underlying disciplines (economics, psychology, and sociology).

Specific topics studied by faculty include: leadership, teams, organizational culture, stress, ethics, motivation, learning and adaptation, individual differences, emotion, organizational attachment, corporate governance, institutional theory, alliance and network strategy, strategy development and implementation, and innovation.

The PhD in business administration with a concentration in management

The doctoral program places emphasis on developing high-quality scholarship, focusing first and foremost on research competence and secondarily on teaching, as a vehicle to academic professionalism.

Our mission is to provide an environment that prepares scholars to assume the diverse responsibilities of tenuretrack faculty positions at leading research universities.

Research focus

Our doctoral students work with mentors to design an individually meaningful program of study, which typically includes coursework and research conducted both individually and with faculty members to fulfill degree requirements. PhD students select a series of department seminars and electives in topics related to organizational behavior, organizational theory, strategic management, and research methods. Pursuing courses in other departments and colleges within the university can further develop knowledge in areas to support students' research interests and chosen area of specialization.

Our full-time, in-residence PhD program takes most students five years to complete. The department has a very collaborative and supportive culture, one where developing and mentoring students is top priority. The department also provides generous financial support throughout the program so students can concentrate on their studies and research.
